COPA is a political action committee that supports both state and federal lawmakers who will speak for and protect the interest of cooperatives and their member-owners. Now more than ever, cooperative members are recognizing the importance of participating in the political process of communicating to our representatives concerns with maintaining affordable electric to rural communities.

Holmes-Wayne Electric Cooperative remains vigilant of ever-changing emission regulations affecting the power plants we rely on every day. Emission regulations should be fair, affordable, and achievable because only a realistic plan can ensure long term success.

In the past, Co-op owners have been instrumental in stopping costly legislation, while remaining committed to a clean environment. Ohio Electric Cooperatives have invested more than \$1 billion over the last decade to upgrade our generating units with state-of-the-art environmental controls. Our base load generation facility, Cardinal Power Plant, is one of the cleanest power plants in the world and meets all guidelines outlined in the Clean Air Act.

We have proven our commitment to being good stewards of the environment while balancing the importance of keeping our electric rates affordable to our members. Enclosed you will see our current generation portfolio that describes the different avenues your cooperative is using to continue in providing reliable, clean, and affordable power.

That's why we ask for your continued support to prevent future regulations that could disproportionately affect cooperative members like you. Member engagement is the heart of the cooperative. Without strong support from our member owners, the traditional grass roots strategy can quickly erode.
