Our organization has additionally worked with middle-school-age children to educate them on the delicate balance between generating energy at an economical price and protecting our environment.

And for children of all ages, we

We also support local youth sports teams. Many of our employees volunteer their time to coach or work in concessions.

HWEC ***TRUSTEE ELECTION***

The board of trustees at Holmes-Wayne Electric Cooperative appointed a nominating committee to select nominees for trustees from their respective districts at its November meeting. The committee consists of six or more members, with at least one member who resides from each district for which a trustee is to be elected.

The nominating committee will meet in January at the cooperative's office to select nominees for trustees from the districts up for election. The districts for which members will be voting for new trustees in June are District 1, District 3 and District 7. The committee selects from the cooperative membership and lists 10 qualified nominees for each trustee position. A

minimum of two names shall be on a ballot to be voted upon for each district.

After selection, nominees are contacted by the HWEC board chairman in the order listed for verification and willingness to become candidates for trustee.

1. Applicants must be a son, daughter or legal ward of an Ohio rural electric distribution cooperative member living on the lines and receiving service at the time of the statewide competition.
2. All applications must be submitted (typed) on forms obtainable from local high school guidance office, or at our website, www.hwecoop.com.
3. All applications must be postmarked or submitted to the office of Holmes-Wayne Electric Cooperative by January 31.
4. Applicants must have all basic credits for college or proper vocational or technical school* entrance. They must have a current career average of "B+" (3.5 on a 4-point scale) or better and must be accepted, then enrolled (when they receive the award), in the accredited college or proper vocational or technical school of their choice.
5. Any applicant who has received a full-tuition scholarship to the school of his/her choice is not eligible for a scholarship from OREC.
6. All scholarships must be accepted in the first academic year after proof of enrollment is received by OREC.
7. Holmes-Wayne Electric Cooperative local 1st place winner in both the boys' and girls' division will be eligible to participate in the statewide competition.
8. Local winners will include both girls and boys division of \$2,500 first place, \$2,000 second place and \$1,500 third place.

*Proper vocational or technical schools must educate beyond high school and credits earned must be transferable to a state-accredited college.
