## Last call to tell EPA — ‘use common sense in rulemaking’

IF IT ONLY TOOK two minutes, would you be willing to help keep your electricity service as reliable and affordable as possible?

That’s it — just two minutes, and you can tell the U.S. Environmental Protection Agency that its newly proposed rule is poised to undermine that notion, at a time when many Americans can least afford it.

**Electric cooperatives like Holmes-Wayne Electric Cooperative, Inc., believe in maintaining a balanced, reasonable approach to generating electricity, using all of the resources available — from coal to natural gas to wind and hydropower.** To us, “balanced” means a national energy policy that ensures affordable, reliable and environmentally responsible electricity for all Americans.

So Holmes-Wayne Electric Cooperative is asking its members to visit [www.action.coop](http://www.action.coop) and file a comment with the EPA, urging the agency to do just that. Be assured that your information is protected and will never be sold.

The EPA’s proposed regulations threaten to end the use of coal at new power plants. Across the U.S., coal is responsible for about 40 percent of all electricity generated. **For Ohio’s elec-**

**tric cooperatives, coal generates more than 90 percent of the electricity used.**

The electricity that powers your home is some of the cleanest generated by coal in the country, thanks to more than \$1 billion in recent investments by Buckeye Power, Holmes-Wayne Electric’s generation facility.

**That’s why we’re asking for your help in putting good old-fashioned common sense into the rules the EPA is creating. We care about clean air and water — but we also care about keeping bills affordable for members like you. We’re simply asking for rules that make sense.**

Would you please visit [www.action.coop](http://www.action.coop) by March 10 and share your opinion with the EPA? The groundwork we lay now sets the stage for June, when the EPA is expected to release its rules for power plants already in operation. What happens now will ultimately affect electricity generation for decades to come.

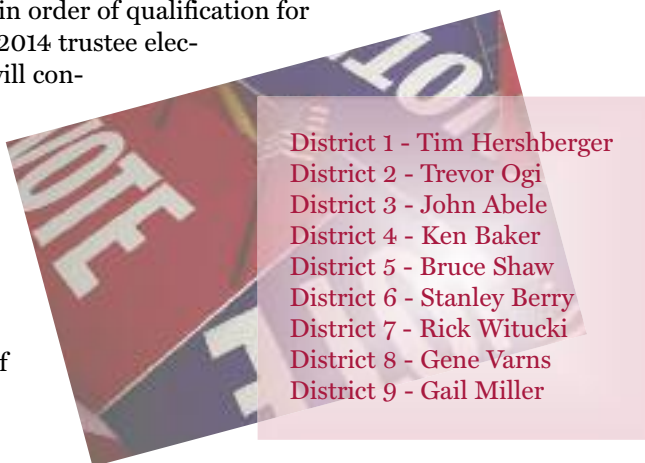
## 2014 HWEC trustee election guidelines

THE 2014 MEETING of the Nominating Committee, appointed by the board of trustees, was held at the Holmes-Wayne Electric Cooperative office in Millersburg on Monday, Jan. 27, 2014. A special thanks to the appointed members for their willingness to work on the Nominating Committee.

The Nominating Committee selected 10 members in order of qualification for each of the three districts (districts 4, 5 and 6) for the 2014 trustee elections. Current Chairman of the Board Randy Sprang will contact the list of potential candidates.

Any member from district 4, 5 or 6 may nominate a trustee candidate for the trustee election in writing by March 13, 2014. The candidate must live within the election district and all nominations must include 15 signatures of members in the election district.

All nominations will be posted at the cooperative office, according to the Holmes-Wayne Electric Code of Regulations.
